# 11. Ordinances - Second Reading

O-25-11 Council President Brown: The following Ordinance was adopted on first reading, advertised according to law, and is now before you for a public hearing and final adoption:

AN ORDINANCE AMENDING CHAPTER 311 "PEDDLING, SOLICITING AND VENDING" ARTICLE IV "STREET VENDORS" SECTION 32 "HOURS LIMITED; FEES" OF THE CODE OF THE CITY OF RAHWAY

**BE IT ORDAINED** by the Municipal Council of the City of Rahway, County of Union, State of New Jersey, as follows:

That Chapter 311, "PEDDLING, SOLICITING AND VENDING", Article IV "Street Vendors" Section 32 "Hours limited; Fees" of the Code of the City of Rahway be and is hereby amended as follows:

# § 311-32 Hours limited; fees:

A. No person shall appear upon any public street within the City from 9:00 p.m. to 8:00 a.m. of the following day for the purpose of or during the process of soliciting a sale or sales or any business, or of displaying food, goods, merchandise or any article whatsoever, or of offering to sell or selling the same to any person.

B. All vendors shall, before offering any goods, wares or merchandise for sale, pay to the City Clerk the sum of \$10 for each anticipated day that vendor intends to offer goods, wares or merchandise for sale on the public streets of the City. Upon payment of such amount and submission of an application, said vendor will receive a license from the City Clerk for said period of days.

**BE IT FURTHER ORDAINED**, if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the Courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provision so adjudicated and the remainder of the Ordinance shall be deemed valid and effective.

**BE IT FURTHER ORDAINED,** any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.

**BE IT FURTHER ORDAINED,** this Ordinance shall take effect upon passage and publication in accordance with applicable law.

# AN ORDINANCE OF THE MUNICIPAL COUNCIL OF THE CITY OF RAHWAY AMENDING THE LOWER MAIN STREET URBAN RENEWAL PLAN PURSUANT TO N.J.S.A. 40A:12A-7

**BE IT ORDAINED** by the Municipal Council of the City of Rahway that the Lower Main Street Urban Renewal Plan adopted on May 9, 1961, last amended on August 13, 2001, pursuant to Ordinance O-38-01, is hereby amended as follows:

1. The Land Use Plan on Page 2 is amended to delete Section C.2. in its entirety and to replace the same with "Mixed-Use Requirements as stated in Section 195-21, M-X/Mixed Use Zone of the Zoning Ordinance of the City of Rahway, except that mid-rise apartments shall be a permitted use on Block 305, Lot 5.04 in accordance with the following requirements:

Minimum lot area: thirty thousand (30,000) square feet

Minimum lot width: seventy-five (75) feet Minimum lot depth: two hundred (200) feet

Minimum building and parking setbacks: none required

Maximum residential density: one hundred forty-three (143) units per acre

Maximum building height: five (5) stories, including one (1) parking level/eighty (80) feet

Maximum building coverage: one hundred (100) percent

Minimum number of parking spaces: one (1) per dwelling unit

**BE IT FURTHER ORDAINED,** that the amendments to the Lower Main Street Urban Renewal Plan are being adopted in accordance with the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-7.

**BE IT FURTHER ORDAINED,** that this Ordinance shall take effect twenty (20) days after publication in accordance with applicable law.

AN ORDINANCE AMENDING CHAPTER 209, "FIRE PREVENTION"
OF THE REVISED GENERAL ORDINANCES OF THE CITY OF
RAHWAY TO CEDE INSPECTIONS FOR LIFE HAZARD USE
PROVISIONS OF THE NEW JERSEY UNIFORM FIRE CODE TO THE
STATE OF NEW JERSEY AND TO TRANSFER RESPONSIBILITY FOR
NON-LIFE HAZARD USE INSPECTIONS FROM THE FIRE
DEPARTMENT TO THE DEPARTMENT OF BUILDING PLANNING
AND ECONOMIC DEVELOPMENT

**BE IT ORDAINED,** by the Municipal Council of the City of Rahway that Chapter 209 "Fire Prevention" of the Code of the City of Rahway be and is hereby amended and supplemented to read as follows:

**SECTION I.** Article I, Section 209-1, Local Enforcement, is hereby amended by the addition of the language "non-life hazard use provisions of the" and the Section and the revised Section shall read as follows:

Pursuant to Section 11 of the Uniform Fire Safety Act (P.L. 1983, c. 383), Editor's Note: See N.J.S.A. 52:27D-202, the non-life hazard use provisions of the New Jersey Uniform Fire Code shall be locally enforced in the Municipality of Rahway.

**SECTION II.** Article I, Section 209-2, Agency Designation, is hereby amended by the deletion of the language "Fire Prevention Bureau of the Rahway Fire Department" and replaced with the language "Department of Building, Planning and Economic Development" and the revised Section shall read as follows:

The local enforcing agency (LEA) shall be the Department of Building, Planning and Economic Development.

**SECTION III.** Article I, Section 209-3, Duties, is hereby amended by the addition of the language "non-life hazard use provisions of the" and the Section and the revised Section shall read as follows:

The local enforcement agency shall enforce the non-life hazard use provisions of the Uniform Fire Safety Act Editor's Note: See N.J.S.A. 52:27D-192 et seq. and the codes and regulations adopted under it in all buildings, structures and premises within the established boundaries of the City of Rahway, other than owner-occupied one- and two-family dwellings, and shall faithfully comply with the requirements of the Uniform Fire Safety Act and the Uniform Fire Code.

**SECTION IV.** Article I, Section 209-4, Life Hazard uses, is hereby amended by the addition of the language "non-" and the deletion of "on behalf of the Commissioner of Community Affairs" and the Section and the revised Section shall read as follows:

The local enforcing agency established by § 209-2 of this chapter shall carry out the periodic inspections of non-life-hazard uses required by the Uniform Fire Code.

**SECTION V.** Article I, Section 209-5, Organization, is hereby amended by the deletion of the language "Rahway Fire Department" and "Director of the Rahway Fire Department" and the addition of "Department of Building Planning and Economic Development" and the Director of the Department of Building Planning and Economic Development" and the revised Section shall read as follows:

The local enforcing agency established by § 209-2 of this chapter shall be a part of the Department of Building, Planning and Economic Development. The local enforcing agency (LEA) shall be under the direct supervision and control of the Fire Official who shall report to the Director of Building, Planning and Economic Development.

**SECTION VI.** Article I, Section 209-6, Appointments; term of office; removal, is hereby amended by the deletion of the language "terms of office" in the heading of the Section; deletion of the language and "Rahway Fire Department"; deletion of the language "Director of the Rahway Fire Department"; deletion of "B. The Fire Official shall serve for a term of one year."; and the addition of "Business Administrator" and the revised Section shall read as follows:

A. The local enforcing agency shall be under the direct supervision of the Fire Official who shall be appointed by the Business Administrator.

- B. Such inspectors and other officials as may be necessary in the local enforcing agency shall be appointed by the Business Administrator.
- C. Inspectors and other employees of the enforcing agency shall be subject to removal by the Business Administrator for inefficiency or misconduct. Each inspector or employee to be so removed shall be afforded an opportunity to be heard by the appointing authority or a designated hearing officer.
- D. The municipality shall specifically appoint legal counsel to assist and represent the local enforcing agency in all matters related to the code. Such legal counsel shall advise the agency and undertake such actions at law as the Fire Official shall deem necessary.

**BE IT FURTHER ORDAINED**, any ordinances or parts thereof in conflict with the provisions of this ordinance are repealed to the extent of such conflict.

**BE IT FURTHER ORDAINED,** this ordinance shall take effect upon adoption and approval in accordance with applicable law.

# AN ORDINANCE ESTABLISHING MANAGEMENT POSITIONS IN THE CITY OF RAHWAY AND PROVIDING FOR COMPENSATION FOR MANAGEMENT EMPLOYEES OF THE CITY OF RAHWAY, NEW JERSEY AND AMENDING ALL ORDINANCES CONCERNING SUCH COMPENSATION HERETOFORE ADOPTED

**IT IS HEREBY ORDAINED** by the Municipal Council of the City of Rahway, New Jersey as follows:

The management positions in the City of Rahway set forth in this Ordinance and not otherwise provided for by law are hereby ORDAINED and established. (Management positions are defined as those positions not included in any bargaining unit.)

All management employees of the City of Rahway shall be compensated at the rates or within the ranges set forth in this Ordinance and shall perform such duties as may be prescribed by the Director of the Department within which they are employed or as may be provided by law.

All rates and ranges are effective July 1, 2011 unless otherwise indicated.

The appointing authority may hire personnel or such additional personnel as may be required on a part-time or temporary basis, to be compensated within available appropriations at a rate or lesser rate than set forth in this Ordinance.

All provisions of this Ordinance are subject to available appropriations and this Ordinance does not and shall not legally bind the City to pay any of the wages or compensations set forth herein unless and until appropriations have been made in sufficient amounts to pay said wages or compensations to those holding the titles and positions set forth herein.

# **SECTION II**

Management employees hired prior to July 1, 1999 shall be paid two percent (2%) of their previous year's base salary as longevity pay for each four (4) years of employment they have completed. Maximum longevity pay is twelve percent (12%).

# **SECTION III**

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to such inconsistencies.

This ordinance shall take effect upon final passage and publication according to law.

Councilmember Mione: Thanked the Fire Department for all of their effort during the hurricane. Commended the Police Department and Public Works for their excellent job. Commented on 9/11 10<sup>th</sup> Anniversary Committee for a great job.

Councilmember Saliga: Commended the Fire Department for their great 9/11 service and the 9/11 Committee for a wonderful memorial service.

Councilmember Baker: Commended the 9/11 Committee for the service and hopes that this will help in the healing process. Councilmember Brown: Said that the investigation will find out the truth. Hurricane Irene was devastating but we did not lose any lives. We all have to continue to help the residents. Thanked Renee Thrash for her help and showing Assemblyman Green's representative around. 65 E. Cherry St. is available for food assistance and that residents should apply to FEMA. Thanked everyone who attended the 9/11 programs. Said that we need to have respect within the City. Thanked Bohler Engineering for help with the Essex St. emergency project.
