#### **GLOSSARY**

"City" - refers to the City of Rahway.

"<u>Statement of Qualifications</u>" (<u>SOQ</u>) or "<u>Qualifications or "Proposal"</u> - refers to the complete responses to this RFQ submitted by the Respondents.

"Qualified Respondent" - refers to those Respondents who (in the sole judgment of the City) have satisfied the criteria set forth in this RFQ.

"Request for Qualifications" (RFQ) - refers to this Request for Qualifications, including any amendments thereof or supplements thereto.

"Respondent" or "Respondents" - refers to the interested firm(s) that submit a SOQ.

#### **SECTION 1**

#### INTRODUCTION AND GENERAL INFORMATION

#### 1.1. <u>Introduction and Purpose</u>.

The City is soliciting Qualifications from interested persons and/or firms for the provision of **2023 ANIMAL CONTROL SERVICES**, as more particularly described herein. Through a Request for Qualifications process described herein, persons and/or firms interested in assisting the City with the provision of such services must prepare and submit a Statement of Qualifications in accordance with the procedure and schedule in this RFQ. The City will review SOQs only from those firms that submit an SOQ, which includes all the information required to be included as described herein (in the sole judgment of the City). The City intends to qualify person(s) and/or firm(s) that (a) possesses the professional, financial and administrative capabilities to provide the proposed services, and (b) will agree to work under the compensation terms and conditions determined by the City to provide the greatest benefit to the taxpayers of Rahway.

#### 1.2. Procurement Process and Schedule.

The selection of a Respondent is not subject to the bidding provisions of the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq. The selection is subject to the "New Jersey Local Unit Payto-Play" Law, N.J.S.A. 19:44A-20.4 et seq., however. The City has structured a procurement process that seeks to obtain the desired results described above, while establishing a competitive process to assure that each person and/or firm is provided an equal opportunity to submit a SOQ in response to the RFQ and will be evaluated in accordance with the criteria set forth in Section 6 of this RFQ, which will be applied in the same manner to each SOQ received. Respondents agree to at all times abide by all requirements of New Jersey law, including, but not limited to the aforementioned "Pay to Play" laws, as well as any and all relevant Executive Orders and the New Jersey Election Law Enforcement Commission disclosure requirements.

Statement of Qualifications will be reviewed and evaluated by the City and its legal and/or financial advisors (collectively, the "Review Team"). #### 2.1 TERMS OF AGREEMENT

The contract shall commence January 1, 2023, shall terminate December 31, 2023, with option to renew for 1 term for 3 years. The contractor shall be paid monthly for providing the services.

#### 2.2 CANCELLATION FOR UNSATISFACTORY PERFORMANCE

Vendors are hereby notified that any contract awarded as a result of this of this request for quotation may be voided without recourse, with thirty (30) calendar days written notification, by certified mail, if services provided under this contract are not complete and satisfactorily performed.

The successful vendor shall not commence any work in connection with the awarded contract until all of the following types of insurance have been obtained and such insurance policies have been approved. All insurance policies shall be obtained from an insurance company authorized to conduct business in the State of New Jersey and one that maintains an office on the State of New Jersey.

The vendor shall furnish proof of insurance coverage by Certificate of Insurance accompanying the contract documents and shall name the City of Rahway as additional insured.

Such Certificate of Insurance shall provide that the insurance company give the City of Rahway thirty (30) days prior of any changes or cancellation terms of such policies during the period of coverage.

The City of Rahway shall be exempt from, and in no way liable for, any sums of money that may represent a deductible in any insurance policy. The payment of any such deductible shall be the sole responsibility of the vendor providing such insurance.

It shall be the responsibility of the successful vendor to maintain in force such insurance policies named herein during the life of this contract.

WORKER'S COMPENSATION INSURANCE, including Occupational Diseases, shall be required of the successful vendor, covering its employees engaged in the work, in accordance with the statutory requirements of the laws of the State of New Jersey. The Worker's Compensation Insurance Policy shall contain an Employee's Liability endorsement providing limits of not less than statutory requirements.

GENERAL PUBLIC LIABILITY INSURANCE shall be required of the successful vendor, which shall also include Products Liability, including losses, injury, or damage resulting from the performance of this agreement, with a limit of not less than \$500,000.00 single limit bodily injury and/or property damage combined from the damages arising out of bodily injury and/or property damage combined from damages arising out of bodily injuries to or death of all persons in any one occurrence and for damages to, and destruction of property including the loss of use thereof in any one occurrence, and \$500,000.00 aggregate property damage per accident.

**AUTOMOBILE LIABILITY INSURNACE** shall be required of the successful vendor, with a limit of not less than \$500,000.00 single limit bodily injury and/or property damage combined for damages arising out of bodily injuries to, or death of all persons in any one occurrence and for damages to, or destruction of property, including the loss of use thereof in any one occurrence covering owned, non-owned, or hired vehicles.

#### **SECTION 4**

#### TECHNICAL SPECIFICATIONS

#### 4.1 SCOPE AND DESCRIPTION OF SERVICES

The City is interested in entering into a contract with a qualified vendor who is able to provide Animal Control Services for the City of Rahway, within the jurisdiction of the City, as detailed and described herein.

The contractor shall be required to provide animal control services as detailed and described herein and in accordance with all regulations established by the State of New Jersey for performing such services. Vendors must be certified by the New Jersey Department of Health as a Certified Animal Control Officer prior to contract award.

The City reserves the right to award the contract for the performance of these services in the manner which is most advantageous to the City.

Once awarded, this contract shall be managed and enforced by the City's Health Officer in conjunction with the City's Qualified Purchasing Agent. All inquiries, invoices and all paperwork submitted for payment shall be directed to the Health Department.

Respondents shall provide on the Official Proposal Form their annual, total, all-inclusive price that they shall charge the City to provide the animal control services as detailed and described herein. Contractor payment shall be made on a monthly basis.

Services to be provided by the contractor within the jurisdiction of the City of Rahway shall include but not be limited to the following:

- A. All services performed under this contract shall conform to the Federal and State requirements in effect at the time of the contract-specifically N.J.S.A. 4:19, 4:22 and 8:23A.
- B. Vendor must have at least (3) years field experience as an Animal Control Officer.
- C. Vendor <u>must</u> hold a New Jersey Animal Control Officer Certification along with their Animal Cruelty Investigators Certification and proof of same <u>must</u> be submitted with proposal. Vendor must also list any additional staff workers and their certifications.
- D. Vendor must establish proper trap-neuter-return (TNR) techniques for free-roaming and feral cat colonies.

- E. The Vendor shall receive and respond to all communications from authorized City personnel and City of Rahway residents/property owners. The contractor shall, within one (1) hour of receipt of said communications, apprehend by proper means, all stray animals and/or animals running at large and small transport them, at the contractor's expense, to a shelter owned and operated by the contractor. The contractor must operate shelter with sufficient capacity to meet the needs of every animal that are admitted from City of Rahway. The contractor shall immediately contact the owners of those animals apprehended that have identification.
- F. Vendor shall be available between the hours of 9:00 A.M. and 5:00 P.M., minimum of five (5) days during a calendar week. Vendor will respond to emergency calls 24 hours per day, 7 days per week.
- G. Telephone calls pertaining to rabid animals, dog bites, and/or dogs which have been hit by a car but are still alive and received between the hours of 5:00 P.M. and 9:00 A.M., weekends and holidays, shall be considered emergencies.
- H. Contractor is to conduct rabies quarantine and release procedures for any animals in a bite as per State Statute.
- I. Owners of free roaming animals will be contacted before transporting them to the New Jersey or Municipal Licensed Animal Shelter.
- J. The Vendor shall provide to the City a telephone number by which residents may contact the contractor when services are required. The contractor shall additionally provide the City with a cellular telephone number, which will not be released to the public, by which the contractor may be reached either by City personnel and/or by the New Jersey State Police. An answering machine will be available to accept calls from the vendor beyond normal working hours. Fax and e-mail communications is strongly suggested in the event of emergencies and for prompt communications with the contract administrator.
- K. Vendor will investigate dog bites and impound animals under the NJ Vicious Dog Law N.J.S.A. 4:19-19. The owner is responsible for removal and boarding costs.
- L. Vendor will provide residents with humane traps for the capture of feral and stray cats. All cat trapping will be conducted to comply with <u>N.J.S.A.</u> 8:23-11 a-h. Vendor will remove contained stray cats during normal business hours only.
- M. The contractor shall provide humane treatment to all animals in conformity with the rules and regulation established by the New Jersey Department of Health.
- N. The Vendor shall complete and maintain all required records and documentation and shall make them available for inspection by authorized City personnel. With the vendors invoice, a listing of the activity shall be submitted and will include specific information to identify the animal and response made to an inquiry (including date, time and outcome of the calls).
- O. The Vendor shall conduct, in accordance with State regulations, regular patrols of the City to apprehend stray and/or running at large animals and to detect possible violations of State and Local animal regulations.

- P. The Vendor will investigate code violations in regard to dogs and cats and issue warnings and summons for violations of said codes. This will also include Municipal Court appearances.
- Q. Contractors shall provide documentation to demonstrate the ability to find alternate housing or accommodations of all animals within 25 calendars days after original pickup date.
- R. The Vendor shall inspect sick and/or injured animals to determine whether they need emergency veterinary care and if so, take the injured animal to a State Licensed Veterinarian or an appropriate 24-Hour Emergency Hospital. The vendor shall cover all veterinary fees.
- S. Contractor is required to collect and dispose of dead animals on city property as requested by the municipality.
- T. The Vendor is responsible for immediately reporting any seized and suspected animal to be rabid to the Rahway Health Department, and reporting wild animal exposure to a domestic animal, or human being. During working hours, 8:30 A.M. to 4:30 P.M. contact either 732-827-2080; weekends, nights and holidays a representative of the Police Department can be reached via 732-827-2200.
- U. Vendor shall provide all necessary equipment needed to patrol and impound sick, stray and injured animals. The vendor shall provide a listing of equipment available to the ACO for use in performing the services under this contract. All vehicles used under this contract shall be equipped with State Approved Animal Transportation Equipment and Vehicles as per N.J.A.C. 8:23A-1.12. The vehicles must\_have current inspection, registration, and insurance. Vehicles shall be made available to the City for inspection.
- V. All primary enclosures such as compartments, cages, etc., used to transport animals in vehicles shall be equipped with supplementary air conditioning and heating to maintain the temperature within the enclosure between 45-85 degrees Fahrenheit at all times when animals are in the enclosure per N.J.A.C. 8:23A-1.12.
- W. Per N.J.S.A. 4:19-15.16b no one shall apply for the position of Animal Control Officer if he/she has been convicted of animal cruelty. If <u>any</u> animal control employee is found guilty, the City will immediately notify the NJDHSS and will terminate that officer.
- X. Under no circumstance will any individual whose ACO certification has been revoked by the State of New Jersey perform any duties under this contract as an ACO. All personnel shall always bear uniforms and carry appropriate identification.
- Y. Vendor will provide a copy of all licensing and insurance documents with the proposal.
- Z. Contractor will notify the City of any Open Public Records Requests received and copy the City of all applicable responses given.

- AA. Vendor agrees to allow non-scheduled inspections of facilities, vehicles, and State Inspection records, by authorized City personnel.
- BB. Vendor <u>must</u> provide monthly and yearly reports. All reports are to be submitted to the Health Officer, De Zheng.

#### **4.2 PAYMENT**

Vendor payment will be made on a monthly basis. A purchase order will be issued from the City of Rahway for these services. With each purchase order a voucher will be submitted for a Claimant Signature. The vendor will sign the voucher and return it, along with an invoice, to the City of Rahway's Health Department.

#### **EVALUATION**

The City's objective in soliciting Qualifications is to enable it to select a firm or organization that will provide high quality and cost-effective services to the citizens of Rahway. The City will consider Qualifications only from firms or organizations that, in the City's judgment, have demonstrated the capability and willingness to provide high quality services to the citizens of the City in the manner described in this RFQ.
